CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 05, 2024, placed the rating(s) of J. G. Rice Mill (JGRM) under the 'issuer non-cooperating' category as JGRM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JGRM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 21, 2025, May 01, 2025, May 11, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

M/s J.G. Rice Mill (JGRM) established and commenced operation from February, 2004. The entity is engaged in processing and milling of non-basmati rice. The milling unit of JGRM is located at Mill – Sirri, Kharora, Raipur, Chhattisgarh, with processing capacity of (Rice – 2856 MTPA, Broken Rice – 1320 MTPA and Rice Bran – 2760 MTPA). JGRM procure paddy from farmers & local agents and sells its products through the wholesalers and distributors across Chhattisgarh.
