### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 27, 2024, placed the rating(s) of Kailash Trading Corporation (KTC) under the 'issuer non-cooperating' category as KTC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KTC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 12, 2025, April 22, 2025, May 02, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

### About the Firm

KTC established in 2001 by Mr. K Chandrasekhar is engaged in trading of engineering and commodity plastics. On the commodity plastics segment KTC acts as a consignment agent of LG and on the engineering plastics segment it imports polymers like hostaform, celanex and sells them to Tier 1 and Tier 2 OEM's of automobile and electronic industries. The firm operates out of Chennai and has a warehouse of capacity 4000 sq. Ft.

**Status of non-cooperation with previous CRA:** ICRA has continued the ratings assigned to the bank facilities of KTC to the 'issuer not-cooperating' category vide press release dated August 14, 2024 on account of its inability to carryout review in the absence of requisite information from the firm.
