Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 05, 2024, placed the rating(s) of Sophisticated Industrial Materials Analytic Labs Private Limited (SIMALPL) under the 'issuer non-cooperating' category as SIMALPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SIMALPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 21, 2025, May 01, 2025, May 11, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to bank facilities of SIMALPL have been revised on account of non-availability of requisite information.

About the company

Sophisticated Industrial Materials Analytic Labs Private Limited (SIMALPL) was incorporated in 1988 and is engaged in testing of drugs, pharmaceuticals, chemicals, cosmetics, dyes & dye intermediates, food & food products, air pollution, noise monitoring etc. The company also undertakes Environment Impact Assessment (EIA) studies. Since 2007, the company has also started undertaking design, Engineering, Procurement and Construction (EPC) of industrial wastewater Treatment Plants (WTPs), Sewage Treatment Plants (STPs) and Common Effluent Treatment Plants (CETP) and also undertakes maintenance of the same. The company has commissioned more than 800 Effluent Treatment Plants and Sewage Treatment Plants on turnkey basis. The company's testing laboratories are located at Mayapuri, New Delhi and Haridwar and it has sample collection centers across North, West and South India.
