## Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 17, 2024, placed the rating(s) of Superfine Bleaching Company Limited (SBCL) under the 'issuer non-cooperating' category as SBCL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SBCL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 02, 2025, April 12, 2025, April 22, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

## **About the Company**

SBCL is a family-run business promoted by Late Mr Soundappan, under the name M/s Veena Processing Mills Limited (VPML) in 1993. The company was earlier engaged in job work of dyeing both fabric and yarn. Subsequently, during October 2005, the company was renamed SBCL and shifted focus to scouring, bleaching and dyeing of yarn alone. The company presently undertakes only job work in dyeing of yarn for players in and around Tiruppur. The company is presently managed by Mr Ravindran, who represents the third generation of the family in the business. SBCL has an installed capacity of dyeing yarn of 10,120 kgs per day as of June 30, 2015, at Namakkal, Tamil Nadu, operating in two shifts. The company has also established the effluent treatment plant which became operational from September 2014.
