### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 24, 2024, placed the rating(s) of J. B. Rolling Mills Limited (JBRML) under the 'issuer non-cooperating' category as JBRML had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JBRML continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 09, 2025, April 19, 2025 and April 29, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of JBRML have been revised on account of non-availability of requisite information.

### About the company

JBRML was initially incorporated in 1996 as Shri Ganpati Ophthalmic Glass (India) Ltd. The name was subsequently changed to Shri Ganpati Concast (India) Ltd (SGCL) in 2003. During 2008, SGCL was acquired by the current promoters and amalgamated with Shri Nilkanth Ispat Udyog Private Limited and J.B Rolling Mills Private Limited (both were promoter group companies in existence since 2003). The resultant entity got its present name (JBRML) vide fresh certificate of incorporation in 2010. JBRML is engaged in the manufacturing of MS Ingots and MS bars/ TMT, MS angle, channel and girders. JBRML sells its products under the brand of "Jai Bharat" which is an established brand of structural steel products in north India, including states such as Himachal Pradesh, Haryana, Uttar Pradesh, Rajasthan other parts of North India.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of JBRML into Issuer Not Cooperating category vide press release dated May 30, 2024 on account of its inability to carry out a review in the absence of the requisite information from the company.

CRISIL has moved the rating assigned to the bank facilities of JBRML to 'Issuer Not Cooperating' category vide press release dated August 13, 2024 on account of its inability to carry out a review in the absence of the requisite information from the company.
