Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 10, 2024, placed the rating(s) of Sunbeam Dealers Private Limited (SDPL) under the 'issuer non-cooperating' category as SDPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SDPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 26, 2025, April 05, 2025, April 15, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Ranchi based Sunbeam Dealers Private Limited (SDPL) was incorporated in August 2013 by the Sarawgi family to initiate a trading business of fabrics. Since its inception, the company has been engaged in trading of cotton, synthetic and grey fabrics. Mr. Amit Sarawgi (aged about 34 years), having around a decade of experience in this line of business, looks after the day to day operations of the company. He is supported by other director Ms. Swati Sarawgi along with a team of experienced professional.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of SDPL into ISSUER NOT COOPERATING category vide press release dated May 21, 2024 on account of its inability to carry out a review in the absence of requisite information from company.
