Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 10, 2024, placed the rating(s) of Sri Venkateswara Mechanical and Electrical Engineering Industries (SVMEEI) under the 'issuer non-cooperating' category as SVMEEI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SVMEEI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 26, 2025, April 05, 2025, April 15, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
