CARE Ratings Limited (CareEdge Ratings) has withdrawn the ratings assigned to the Bank facilities of S.P.Y. The group is based out of Nandyal (Andhra Pradesh) and has presence in other businesses such as cement, dairy, PVC pipes, construction, TMT bars etc.
