Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 23, 2024, placed the rating(s) of Sri Rathna Lakshmi Spinning Mills Private Limited (SRLSMPL) under the 'issuer non-cooperating' category as SRLSMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SRLSMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 08, 2025, April 18, 2025, April 28, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
