Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 24, 2024, placed the rating(s) of Sree Karpagamoorthy Automobiles (SKA) under the 'issuer non-cooperating' category as SKA had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SKA continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 09, 2025, April 19, 2025, April 29, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The registered office of the firm is located in Karaikudi, Sivagangai district Tamil Nadu. It has four other branches and one stock yard in Sivagangai and Ramanathapuram districts of Tamil Nadu. The firm is the authorised dealer of TATA motors Limited for Heavy and Light commercial vehicles. The firm's revenue is predominantly attracted from sale of TATA ACE range of models, popularly known as "Chota Hathi". It is also involved in purchase and sale of spare parts, accessories and auxiliary items and services of TATA motor automobiles. The firm purchases vehicles and spare parts directly from TML manufacturing units in Gurgoan, Bangalore, Pantnagar, and Kolkata.
