Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 05, 2024, placed the rating(s) of Susheela Texfab Private Limited (STPL) under the 'issuer non-cooperating' category as STPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. STPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 21, 2025, May 01, 2025, May 11, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

SPL is currently engaged in manufacturing of various types of knitted fabrics. The manufacturing unit is located at Pilkhuwa, Uttar Pradesh, with installed capacity of 3,500 metric tonne per annum as on February 28, 2018. The major raw materials are cotton yarn and dyes which the company procures from various spinning mills across the country. The company caters to domestic as well as international market.
