Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 29, 2024, placed the rating(s) of Stefina Vitrified Private Limited (SVPL) under the 'issuer non-cooperating' category as SVPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SVPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 14, 2025, April 24, 2025, May 04, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the company

Morbi (Gujarat) based SVPL was incorporated in January 2016 by Mr. Manojkumar Vilpara, Mr. Hiteshbhai Vilpara and Mr. Rajeshbhai Vilpara. It has set up its plant in Morbi for manufacturing of vitrified tiles of various sizes varying from 600 mm x 600 mm to 1600 mm x 4800 mm and operates with an installed capacity of 65,100 metric tonnes per annum. Commercial production of SVPL commenced from March 2017 onwards.
