### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 19, 2024, placed the rating(s) of Mangalam Ventures Limited (MVL) under the 'issuer non-cooperating' category as MVL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MVL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 05, 2025, May 15, 2025 and May 25, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings have been revised on account of non-availability of requisite information.

Incorporated in 1993, MVL is managed by Vinod Ahuja, Sharat Jain, and Ramakant Shivasamb Hegde, and, is engaged in manufacturing and exporting readymade knitted garments primarily to Canada, and the USA. The company manufactures and supplies products including knitwear garments, cotton knitted fabrics, and cotton knitted processed fabrics. MVL has its manufacturing facility at Faridabad, Uttar Pradesh, where inhouse dyeing, cutting, stitching, and packaging are carried out by the company). The company is approved by Worldwide Responsible Accredited Production (WRAP) and Business Social Compliance Initiative (BSCI) and accredited by Control Union Certifications for producing 100% Organic and Organic blend garments.
