# Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 11, 2024, placed the rating(s) of Champa Bitumen Hot Mixture Plant (CBHMP) under the 'issuer non-cooperating' category as CBHMP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. CBHMP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 27, 2025, May 07, 2025, May 17, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings. has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.
