Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 29, 2024, placed the rating(s) of Varshini Fertilizer Private Limited (VFPL) under the 'issuer non-cooperating' category as VFPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VFPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 14, 2025, April 24, 2025 and May 04, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Varshini Fertilizer Pvt Ltd (VFPL) was incorporated on December 14,2012 as Amrutha Varshini Organic Fertilizers Private Limited, however was rechristened as Varshini Fertilizer Private Limited on August 13,2018. Earlier, the company was used for trading activities by the promoters as and when required. However, now the company is in the process of setting up of biopesticide plant and is expected to commence manufacturing of the same from April'23 onwards.
