Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 10, 2024, placed the rating(s) of Shree Jagdamba Poultry Private Limited (SJPPL) under the 'issuer non-cooperating' category as SJPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SJPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 26, 2025, May 06, 2025 and May 16, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Nagpur, Maharashtra based, SJPPL was incorporated in 2001 as a private limited company by Mr. Rakesh Singh and Ms. Nutan Rakesh Singh, and is engaged in poultry farming business and trading of agro products like paddy, maize, wheat, rice, soyabean, animal and poultry feed amongst others.

Status of non-cooperation with previous CRA: ICRA has continued the rating assigned to the bank facilities of SJPPL under Issuer Not Cooperating category vide press release dated September 27, 2024 on account of its inability to carry out a review in the absence of the requisite information from the company.
