Rationale & Key Rating Drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated May 17, 2024, placed the rating(s) of Sri Ram Technopack Private Limited (SRTPL) under the 'issuer non-cooperating' category as SRTPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SRTPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 02, 2025, April 12, 2025, April 22, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
