## Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 06, 2024, placed the rating(s) of Gali Jagadish Chandra Prakash (GJCP) under the 'issuer non-cooperating' category as GJCP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GJCP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 22, 2025, April 01, 2025, April 11, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
