Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 20, 2024, placed the rating(s) of Deepak Singal Engineers and Builders Private Limited (DSEBPL) under the 'issuer non-cooperating' category as DSEBPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DSEBPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 06, 2025, May 16, 2025 and May 26, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to bank facilities of DSEBPL have been revised on account of non-availability of requisite information.

The company is a part of the 'Deepak' group having business interest in civil construction and real estate. DSEBPL has a group company- Deepak Builders & Engineers India Pvt. Ltd. which is also engaged in the same line of business since 1987.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of DSEBPL into 'Issuer not-cooperating' category vide press release dated June 29, 2024 on account of non-availability of requisite information from the company.
