### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 18, 2024, placed the rating(s) of Omshree Agro Tech Private Limited (OATPL) under the 'issuer non-cooperating' category as OATPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. OATPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 04, 2025, May 14, 2025 and May 24, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings have been revised on account of non-availability of requisite information.

### **About the company**

Omshree Agro Tech Private Limited (OATPL) erstwhile Omshree Agro Tech Limited was incorporated in June 2004. In 2016, the company was reconstituted into Private Limited Company with the name changed to current one. The company is engaged in extraction of refined oil, de-oiled cake, soya toasted flour, soya hulls and soya grits from soya bean. OATPL's manufacturing facility is located in Dhule in the state of Maharashtra with a cumulative installed capacity of about 450 Tonnes per Day (TPD) for soybean seeds processing of all the products. OATPL is the flagship company of the Omshree group having presence across the solvent extraction value chain, cotton industry and cattle feed industry.
