Rationale & Key Rating Drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 31, 2024, placed the rating(s) of Shree Ganesh Jewellers Limited (SGJL) under the 'issuer non-cooperating' category as SGJL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SGJL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 16, 2025, April 26, 2025, May 06, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of SGJL have been revised on account of non-availability of requisite information.
