## Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 10, 2024, placed the rating(s) of Precision Electronic Instruments Company (PEIC) under the 'issuer non-cooperating' category as PEIC had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. PEIC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 26, 2025, May 06, 2025, May 16, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

#### **About the Firm**

Bahadurgarh, Distt. Jhajjar, Haryana based Precision Electronic Instruments Company (PEIC) is a proprietorship firm established in January, 1999. The firm is managed by Mr. Rajnish Kumar Aggarwal. PEIC is engaged in manufacturing of Digital Weighing Scales, weigh bridges, weighing systems, load cells, Auto/taxi fare meter and LED lighting.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of PEIC into Issuer Not Cooperating category vide press release dated July 11, 2024 on account of its inability to carry out a review in the absence of requisite information.

CRISIL has continued the rating assigned to the bank facilities of PEIC into Issuer Not Cooperating category vide press release dated October 22, 2024 on account of its inability to carry out a review in the absence of requisite information.
