Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 30, 2024, placed the rating(s) of Roy Apparels Private Limited (RAPL) under the 'issuer non-cooperating' category as RAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 15, 2025, April 25, 2025, May 05, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of RAPL have been revised on account of non-availability of requisite information.

About the company

Roy Apparels Private Limited (RAPL) was incorporated on April 08, 2008 and the registered office of the company is situated at Kolkata, West Bengal. Since its inception, the company has been engaged in manufacturing of apparels such as T-shirts, caps, shirts, trousers, sportswear, jackets, sweat shirts for advertising & promotions or even everyday work-wear for corporates as per their specification. Currently the company has four manufacturing units located in Kolkata (2 units) and South 24 Parganas (2 units) with an aggregate installed capacity of 10,000 pieces of apparels per day. The unit-3 and unit-4 plants which are located in South 24 Parganas have started the commercial operations in October 2017 and March 2018 respectively. Further the company has availed moratorium on interest and principal repayment of term loan from its lender (Deutsche Bank; facility not rated by CARE) from March 2020 to August 2020.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of RAPL into ISSUER NOT COOPERATING category vide press release dated November 21, 2024 on account of its inability to carry out a review in the absence of requisite information.
