Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 24, 2024, placed the rating(s) of Nilkanth Kraft Paper Mill (NKPM) under the 'issuer non-cooperating' category as NKPM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. NKPM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 09, 2025, April 19, 2025, April 29, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Mehsana-based (Gujarat), NKPM was established in July 2015 by total 11 partners. Further, the partnership deed has been revised in December 2020 and at present it is managed by 6 partners. The firm is engaged into business of manufacturing Kraft & Absorbent Paper and operating from its unit located at Mehsana having installed capacity of 36,000 Metric Ton Per Annum as on March 31, 2021.
