# Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 30, 2024, placed the rating(s) of Vedik Ispat Private Limited (VIPL) under the 'issuer non-cooperating' category as VIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 15, 2025, April 25, 2025, May 05, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

# About the company

Vedik Ispat Pvt. Ltd. (VIPL), incorporated in 1992, was a dormant company till 2010. In 2010, it started a project to set up a hot and cold-rolled sheets facility in Hindupur (AP), which started commercial activity in 2011, with an installed capacity of 72,000 TPA of slabs/billets. The plant has capability to produce both Mild Steel (MS) and Stainless Steel (SS) products. The company undertook installation of Annealing pickling plant to process HR coils as a part of its forward integration strategy. Apart from the above, VIPL is also engaged in trading of TMT bars, MS Pipes, angels and ingots.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of VIPL into ISSUER NOT COOPERATING category vide press release dated January 28, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
