## **Rationale and key rating drivers**

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 04, 2024, placed the rating(s) of Sri Mahaganapathi Cashew Industries (SMCI) under the 'issuer non-cooperating' category as SMCI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SMCI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 20, 2025, April 30, 2025 and May 10, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

# About the firm

Sri Mahaganapathi Cashew Industries (SMCI) was established in the year 2014 as partnership firm and promoted by Mr. P Ganesh Kamath, Ms. Mamatha G Kamath, Ms. K Smitha Kamath and Mr. Rajesh Kamath. The firm is engaged in processing of raw cashew kernels. The firm sells the processed cashew kernels in Bangalore, Mangalore, Mumbai, Delhi and Punjab. The firm procures raw cashew kernels from international market places like Benin (West Africa) and Tanzania (East Africa). The firm exports 25% of cashew kernels to international markets like Dubai and Europe. Currently, the day to day operations of the firm are managed by Mr. P Ganesh Kamath (Managing Partner).

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of SMCI into Issuer Not Cooperating category vide press release dated July 08, 2024 on account of its inability to carry out a review in the absence of requisite information.
