### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 10, 2024, placed the rating(s) of Musaddilal Mansaram Rice Mill (MMRM) under the 'issuer non-cooperating' category as MMRM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MMRM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 26, 2025, May 06, 2025, May 16, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Musaddilal Mansaram Rice Mill was established in February 1995 with an objective to enter into the rice milling and processing business. It is a partnership entity, currently carrying out the business by three partners. The manufacturing unit of the entity is located in Raigarh, Chhattisgarh. The entity is procuring raw paddy from the local farmers and small paddy agents for own milling and from FCI for custom milling. Mr. Bajranglal Agarwal (Partner) along with other partners Mr. Sanjay Kumar Agarwal and Mr. Manoj Kumar Agarwal who have around 23 years, 20 years and 30 years of experiences, respectively, in similar line of business, are looking after the day to day operation of the entity.
