Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 23, 2024, placed the rating(s) of Anthony Garments Private Limited (AGPL) under the 'issuer non-cooperating' category as AGPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AGPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 08, 2025, April 18, 2025, April 28, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of AGPL have been revised on account of non-availability of requisite information.

Anthony Garments Private Limited (AGPL) incorporated in the year 2004 by Mr. Joseph Anthony is located at Tirupur, Tamil Nadu. AGPL is engaged in manufacturing and exports of knitwear garments with major focus on ladies/kids wear to Europe. AGPL has 572 sewing machines with stitching capacity of 19000 pieces per day as on March 23, 2022. AGPL also has rotary printing unit established in the year 2017.

Status of non-cooperation with previous CRA: ICRA has moved the rating assigned to the bank facilities of AGPL into Issuer Not Cooperating category vide press release dated June 06, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company.
