### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 04, 2024, placed the rating(s) of Radha Krishna Rice Mill (RKRM) under the 'issuer non-cooperating' category as RKRM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RKRM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 20, 2025, April 30, 2025 and May 10, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### **About the firm**

Radha Krishna Rice Mill was established in 1989 with an objective to enter into the rice milling and processing business. The entity started its commercial operation from March 1989. The manufacturing unit of the entity is located at Paragaon, Nawapara, Rajim Dist, Raipur-493881, Chhattisgarh. The current installed capacity of the unit is 21,600 metric tons per annum (MTPA). The entity primarily procures paddy from farmers & local agents located in Chhattisgarh and other neighboring states. Further the firm is also engaged in custom milling on behalf of Chhattisgarh government aggregating to 1-2% of TOI in FY18. Mr. Mohan Lal Agarwal (proprietors) manages the day-to-day operations of the business along other partner and with a team of expert professionals who are having a long experience in the similar line of business.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of RKRM into Issuer Not Cooperating category vide press release dated February 25, 2025 on account of its inability to carry out a review in the absence of requisite information.
