### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 27, 2024, placed the rating(s) of Swastik Housing & Construction (SHC) under the 'issuer non-cooperating' category as SHC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SHC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 12, 2025, April 22, 2025, May 02, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

SHC secures its major portion of tenders through open bidding from Indian Oil Corporation Limited (IOCL) and Hindustan Petroleum Corporation Limited (HPCL). The firm also gets work contract from other government entities and private parties too. The firm is registered as approved contractor with PWD department, Government of Madhya Pradesh. The firm has successfully completed various construction projects majorly in Madhya Pradesh.
