Rationale & Key Rating Drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 02, 2024, placed the rating(s) of Shirpur Gold DMCC (SGD) under the 'issuer non-cooperating' category as SGD had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SGD continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 18, 2025, May 28, 2025, June 07, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the company

Shirpur Gold DMCC (SGD; erstwhile Zee Gold DMCC) is a part of Essel group with 100% holding of Shirpur Gold Refinery Limited (SGRL; rated CARE D; Issuer Not Cooperating vide its PR dated July 01, 2024). SGD commenced its commercial activities from January 05, 2016. SGD is broker member of Dubai Gold & Commodities Exchange. The company is engaged in processing (Outsourced) and trading of gold bars from gold dore. SGD procures raw material (dore) from Latin America and sells largely in Dubai market. SGD has tie up with mining companies from gold producing countries in Latin America, Australia, Africa etc. to ensure proper and regular supply of gold dore. Post procurement, refining is done through Dubai Good Delivery refiners like Al Etihad Gold Refinery DMCC, Dubai. After getting the refined bars of 99.5% purity the same are sold to bullion banks like Standard Bank of London, RAK Bank Dubai and other wholesale traders in Dubai. SGD acquired 70% stake in Metalli Exploration and Mining (MEAM) in Mali, Bodoko in FY2018.
