Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 12, 2024, placed the rating(s) of DPS Contractors Private Limited (DCPL) under the 'issuer non-cooperating' category as DCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 28, 2025, May 08, 2025, May 18, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of DCPL have been revised on account of non-availability of requisite information.

DPS Contractors Private Limited (DCPL) was incorporated by Mr. Dinesh Pratap Singh and Mr. Brijesh Pratap Singh in 2007. Currently, the management comprises of Mr. Ram Khelwan and Mr. Ram Vilas and Mr. Brijesh Pratap Singh. The company is engaged in civil construction work which involves building of roads, bridges, pipelines and canals. DCPL executes the projects mainly for Public Work Department (PWD), Indian Railways, National Highway Authority of India (NHAI) etc. The company mainly operates in Uttar Pradesh.
