# Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 03, 2024, placed the rating(s) of Shiv Sundar & Company (SSC) under the 'issuer non-cooperating' category as SSC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SSC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 19, 2025, May 29, 2025, June 08, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

SSC was formed in December, 2011 as a partnership concern by Mr. Dinesh Verma along with his family members. SSC was established with an objective to set up two-star hotel in Indore (Madhya Pradesh). The hotel has started commercial operations from July 2017 and has facility of total 52 rooms which includes; 4 suits, 12 Deluxe/Super Deluxe rooms and 36 Simple rooms along with separate Vegetarian and Non-Vegetarian restaurant and bar, Gym, Spa as well as two banquet halls and marriage garden of 26000 Sq. Ft.
