Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 24, 2024, placed the rating(s) of Dewan Chand (DC) under the 'issuer non-cooperating' category as DC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 10, 2025, May 20, 2025 and May 30, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

DC was initially established as proprietorship concern and later on converted into a partnership firm on August 29, 2009. DC is Delhi-based firm managed by Mr Vikram Phalper along with his wife Mrs Anita Phalper for carrying out different types of civil construction projects for Public Works Department (PWD) Delhi. DC was founded in 1949 by late Lala Mr Dewan Chand. DC is registered as a Class A contractor with PWD, Delhi, and has tendered various contracts involving contracts of government buildings since inception. It has completed prestigious contracts namely Indra Prastha Bhawan, Ashoka Estate Building, World health house, Indian Oil Bhawan, Police head Quarters, etc. DC is present majorly in Delhi.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of DC into Issuer Not Cooperating category vide press release dated September 11, 2024 on account of its inability to carry out a review in the absence of requisite information.
