Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 15, 2024, placed the rating(s) of Deneb And Pollux Tours And Travels Private Limited (DPTTPL) under the 'issuer non-cooperating' category as DPTTPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DPTTPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 31, 2025, June 10, 2025, June 20, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of DPTTPL have been revised on account of non-availability of requisite information.
