Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 04, 2024, placed the rating(s) of Hindustan Textiles (HT) under the 'issuer non-cooperating' category as HT had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. HT continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 20, 2025, April 30, 2025, May 10, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of HT have been revised on account of non-availability of requisite information.

Hindustan Textiles (HT) was established as a partnership concern by Mr. D.Natarajan, Mrs. N.Vanithamani and Mr.N.Krishnakumar with a motive to set up a family business operation in the year 1977 at Coimbatore, Tamil Nadu. The firm is engaged in manufacturing of cotton yarn in the count's range of 34s and 40s, at its two manufacturing facilities, located at MTP Road, Vadamadurai (Unit-A) and T.M. Palayam Jothipuram (Unit-B), with an aggregate installed capacity of 38832 spindles as on February 24, 2022.
