### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 04, 2024, placed the rating(s) of Geotrix Building Envelope Private Limited (GBEPL) under the 'issuer non-cooperating' category as GBEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GBEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 20, 2025, April 30, 2025, May 10, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Geotrix Building Envelope Private Limited (GBEPL) was established in April, 2011 as a private limited Company. The key directors include Mr. Selvam Ramanatham as the managing director, Mr. Abdul Gafoor Khan as the other director and Mr. Sridhar as independent director. GBEPL is engaged in designing and manufacturing of Architectural Aluminium and Glass unitized curtain walls, ACP cladding and Allied works including Installation.
