Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 14, 2024, placed the rating(s) of Sri Anu Hospitals Limited (SAHL) under the 'issuer non-cooperating' category as SAHL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SAHL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 30, 2025, May 10, 2025, May 20, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of SAHL have been revised on account of non-availability of requisite information.

About the Company

Sri Anu Hospitals Private Limited (SAHPL) was incorporated in 2012 as a multi-specialty hospital in Vijayawada, Andhra Pradesh and is promoted by Dr. Ramesh Gajula, a practicing Laparoscopic surgeon with more than a decade experience in the medical field. Dr. Ramesh Gajula is the Chairman and Managing Director of the company, and is joined by the other directors, who are doctors by profession with having extensive experience in the medical field. SAHPL is a flagship hospital for the Sri Anu Hospital group. SAHPL runs 2 hospitals located in Vijayawada, Andhra Pradesh under the brand "SRIANU Hospitals" with a cumulative operating- capacity of 200 beds divided into 100 beds each. In 2021 the company has added one more hospital by way of acquiring Medicover Hospital in Visakhapatnam. The hospital offers a wide range of services in various specialty segments like, Gastro Entomology, Nephrology, Urology, Pulmonology, Orthopaedics, General Medicine, Paediatric Surgery, Paediatric Orthopaedics, Diabetology, Mother & child care along with general surgery. The company also operates via its Subsidiary hospital company Anu My Baby Hospitals Private Limited, which has common promoter. The name of the company has been changed from Sri Anu Hospitals Private Limited to Sri Anu Hospitals Limited from June 01, 2022.

Status of non-cooperation with previous CRA: Acuite has continued the ratings assigned to the bank facilities of SAHL to the 'issuer not-cooperating' category vide press release dated July 18, 2025 on account of its inability to carryout review in the absence of requisite information from the company.
