Rationale & Key Rating Drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 15, 2024, placed the rating(s) of UI Fabricators Private Limited (UFPL) under the 'issuer non-cooperating' category as UFPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. UFPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 31, 2025, June 10, 2025, June 20, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Incorporated in the July 2016, UI Fabricators Private Limited (UIFPL) is engaged into business of manufacturing of LPG cylinders (domestic as well as industrial cylinder). The company has undertaken to manufacture LPG cylinders in September 2016 at its plant located at Sitarganj district, Uttarakhand. The key raw material i.e., steel is sourced from local suppliers (namely from Tata Steel Limited) and orders are procured through tender-bidding process (namely from Indian Oil, Hindustan Petroleum and Bharat Petroleum).
