Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 06, 2024, placed the rating(s) of Fab Tool Industries (FTI) under the 'issuer non-cooperating' category as FTI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. FTI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 22, 2025, May 02, 2025, May 12, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Fab Tool Industries (FTI) was established in the year 1997 as a partnership firm and promoted by Mr. Srinivasa Reddy and Mrs. Sarala (Spouse of Mr Srinivasa Reddy). The firm is engaged in manufacturing of fabrication of heavy metal components like construction of mining equipment, power plant equipment, tyre curing and tyre building machinery parts, power transformer tanks, general and custom-built engineering fabrication including precision machinery. The firm operates its business from two manufacturing facilities i.e., Unit- I is spread over in total area of 1 acre in Bommenahalli road, Old Madras road, Virgonagar Post, Bangalore (Karnataka) and Unit II is spread across in total area of 3 acres, KIADB Industrial area, 4th phase, Malur, Kolar District (Karnataka).
