## Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 03, 2024, placed the rating(s) of Theme Music Company Private Limited (TMCPL) under the 'issuer non-cooperating' category as TMCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. TMCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 19, 2025, May 29, 2025, June 08, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of TMCPL have been revised on account of non-availability of requisite information.

#### **About the company**

New Delhi based, Theme Music Company Private Limited (TMCPL) was incorporated in August 2008 as a Private Limited Company. The company is being managed by Mr. Bhupendra Chaturvedi, Mrs. Sangeeta Chaturvedi, Mr. Rajendra Chaturvedi and Mrs. Renu Chaturvedi. The company is engaged in trading of pianos. It mainly imports pianos from Kawai Musical Instruments Manufacturing Co. Ltd. located in Japan. TMPL is sole distributor of Kawai's Piano in India.

**Status of non-cooperation with previous CRA:** Acuite (SMERA) has continued the rating assigned to the bank facilities of TMCPL into Issuer Not Cooperating category vide press release dated September 2,2024 on account of its inability to carry out a review in the absence of requisite information.
