## Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 04, 2024, placed the rating(s) of Bhardwaj Construction Company Private Limited (BCCPL) under the 'issuer non-cooperating' category as BCCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BCCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 20, 2025, April 30, 2025, May 10, 2025 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of BCCPL have been revised on account of non-availability of requisite information.

Since its inception, the company has been engaged in civil construction business in the segment like roads, bridges, irrigation cannels etc. Mr. Jai Durga Pathak (Director), along with other directors, Mr. Jai Shankar Pathak, Mrs. Deoki Devi, Mr. Riaz Ahmed, Mr. Gopal Pathak and Mr. Jai Pathak Uma Shankar have significant experience in the civil construction business look after the day-to-day operation of the company.

**Status of non-cooperation with previous CRA:** India Ratings has continued the rating assigned to the bank facilities of BCCPL into ISSUER NOT COOPERATING category vide press release dated April 10, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
