Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 09, 2024, placed the rating(s) of Tejas Agro Irrigation Systems Private Limited (TAISPL) under the 'issuer non-cooperating' category as TAISPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. TAISPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 25, 2025, June 04, 2025, June 14, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The company manufactures a diverse range of pipes and fittings with a product portfolio of 750 products with various types of moulded and fabricated fittings.
