Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 09, 2024, placed the rating(s) of Surya Laxmi Industries (SLI) under the 'issuer non-cooperating' category as SLI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SLI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 25, 2025, June 04, 2025, June 14, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Delhi based, Surya Laxmi Industries (SLI) was established on March 23, 2011 as a partnership firm by Mr. Tarun Karnany, Mr. Rohit Karnany. SLI manufactures non-woven fabric, medical non-woven fabric, shopping bags, agricultural non-woven material and rice & pulses packaging bags at its manufacturing facility located in Khasra, Delhi

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of SLI into Issuer Not Cooperating category vide press release dated July 8, 2024 on account of its inability to carry out a review in the absence of requisite information.

Acuite has continued the rating assigned to the bank facilities of SLI into Issuer Not Cooperating category vide press release dated December 18, 2024 on account of its inability to carry out a review in the absence of requisite information.
