# Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 08, 2024, placed the rating(s) of Greenergy Wind Corporation Private Limited (GWCPL) under the 'issuer non-cooperating' category as GWCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GWCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 24, 2025, April 03, 2025, April 13, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of GWCPL have been revised on account of non-availability of requisite information.

Greenergy Wind Corporation P Ltd. (GWCPL), part of Golden Group of companies, is into generation of wind power under group captive scheme. The company has wind farm assets with cumulative capacity of 16MW in Gadag and Belgaum districts of Karnataka. Subsequently, it acquired 6.5MW of assets from group company, Golden Hatcheries and is in process of acquiring another 1.7MW of asset from GOH.
