### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 04, 2024, placed the rating(s) of SAR Clothing (India) Private Limited (SCPL) under the 'issuer non-cooperating' category as SCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 20, 2025, April 30, 2025, May 10, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

SAR Clothing (India) Private Ltd (SCPL) was incorporated in December, 2012 by Raghani family of Kolkata, West Bengal with Shri Satish U. Raghani being the main promoter. Since its inception, SCPL has been engaged in manufacturing and export of readymade garments. The manufacturing facility of the company is located in Kolkata with an aggregate installed capacity of 27,00,000 pieces per annum. The company generates revenue fully from export activities. The major export destinations of SCPL are UAE, Saudi Arabia etc. Mr. Satish U. Raghani, aged about 59 years, having more than two decades of experience in garments manufacturing, export and trading activities, looks after the overall management of the company. He is also assisted by other director and a team of experienced personnel.
