Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had vide its press release dated April 01, 2021, placed the rating(s) of India Home Loan Limited (IHLL) under the 'issuer non-cooperating' category as IHLL had failed to provide information for monitoring ratings and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. IHLL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated June 10, 2025, June 15, 2025, and June 19, 2025. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating basis the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Delays in debt servicing

There has been a delay in servicing of debt instruments considering poor liquidity and operational difficulties. There have been ongoing delays in servicing of debt instruments considering poor liquidity. IHLL has mentioned delay in servicing on its debt obligations in the monthly declaration to CareEdge Ratings dated July 01, 2023, for June 2023 and has intimated on BSE regarding default on principal repayment of non-convertible debenture, which was due on June 30, 2023, post which the company has not provided monthly declaration on default status to CareEdge Ratings.
