## Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 13, 2024, placed the rating(s) of Tanuj Roshi Poultry Farm (TRPF) under the 'issuer non-cooperating' category as TRPF had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. TRPF continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 29, 2025, May 09, 2025, May 19, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

## **About the firm**

Tanuj Roshi Poultry Farm (TRPF) was established in 1990 as a proprietorship concern by Mrs. Shashi Kala Gupta. TRPF is engaged in the poultry farming business at its farm located in District Ambala, Haryana with a breeding capacity of 3,15,000-layer birds per batch. The firm sells eggs and cull birds to various wholesalers located in Punjab and Delhi. Also, the firm is registered vendor at Amazon, Flipkart, Best Price, Metro, Big Basket and More. The main raw material is 1-day old chick and also requires maize, soyabean, mustard, rice bran, proteins and deoiled rice bran for feeding the chicken. The same is procured through traders/ agents located in Rajasthan, Gujarat and Uttar Pradesh. Besides TRPF, the proprietor is also engaged in managing another group concern namely Jai Shree Ganesh.
