## **Rationale and key rating drivers**

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 04, 2024, placed the rating(s) of Mallikharjuna Agencies (MA) under the 'issuer non-cooperating' category as MA had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MA continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 20, 2025, April 30, 2025, May 10, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

#### **About the Firm**

Incorporated in August 10 2004, Mallikharjuna Agencies (MA) was promoted by Mr. Ashok Kumar Reddy (Managing Partner) and Mr. Kamlesh Kumar Reddy (Partner). The firm is engaged in the wholesale trading of wines (MGM Wine & Spirits, 5000 super premium, Troubadour megma etc.,). the firm purchases the products from companies like Privilege Industries Limited and etc and sells the same to dealers located in Puducherry.

**Status of non-cooperation with previous CRA:** CRISIL has continued the ratings assigned to the bank facilities of MA to the 'issuer not-cooperating' category vide press release dated December 12, 2024 on account of its inability to carryout review in the absence of requisite information from the firm.
