# Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 21, 2024, placed the rating(s) of Omkar Infracon Private Limited (OIPL) under the 'issuer non-cooperating' category as OIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. OIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 07, 2025, May 17, 2025, May 27, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of OIPL have been revised on account of non-availability of requisite information.

## **About the company**

Incorporated in February 2010, Omkar Infracon Private Ltd (OIPL) was promoted by Mr. Sandeep Khandelia and Mr. Shankar Saraf based out of Kolkata, West Bengal. The company has commenced its commercial operations from August 01, 2012 onwards and it has been engaged in manufacturing of different types of fly ash bricks which is mainly used in construction and real estate industries. The company is also engaged in real estate activities like purchase of land, land development and selling out the lands; however, the company derived minor revenue from real estate activities. The manufacturing unit of the company is located at Howrah, West Bengal. Both the promoters; Mr. Sandeep Khandelia and Mr. Shankar Saraf, have around two decades of experience, in similar line of business, they look after the day-to-day operation of the company.

**Status of non-cooperation with previous CRA:** India Ratings has continued the rating assigned to the bank facilities of OIPL into Issuer Not Cooperating category vide press release dated February 11, 2025 on account of its inability to carry out a review in the absence of requisite information.
